Minutes of the Parish Council Meeting 7/12/2021

In the absence of CIIr Dolley CIIr Warne chaired the meeting and at the commencement asked the meeting for a minutes silence in respect of the passing of Mrs Dolley.

APOLOGIES Clir Dolley.

DECLARATIONS OF INTEREST

Cllr Moore declared an interest in payments.

PUBLIC FORUM

There were 8 members of the public present.

Mr. Renfree explained the system of wild camping at Bush Farm and considered the camping did not exceed 56 days in any one location. Mr. Renfree asked that people should contact him if they had any issues.

MINUTES

The minutes of 2nd November 2021 Council meeting were accepted unanimously.

MATTERS ARISING

- a) The Chairman explained that the Council had a duty to report apparent planning breaches and that the matter of wild camping was now in the hands of Cornwall planning authority.
- b) The results of meeting with Cornwall Highways were outlined, and it was noted that Cornwall Highways agreed, subject to budget restraints to; heightening the ramp at the Weary Friar car park, replacing a drain cover and clearing debris at Pillaton Mill and writing to the land owner regarding debris washed down at Barton Meadow. It was noted that moving speed signs required a Traffic regulation order which could be funded through the CNA panel. In the meantime it was hoped that warning signs could be erected.
- c) Cllr Johnson updated the meeting on the proposed and costing of additional equipment and outlined possible sources of funds. The Council supported assistance in funding the scheme.

PLANNING APPLICATIONS.

The Council approved the following applications;

- a) PA21/08430 conversion of outbuildings into 2 holiday units at the Weary Friar for Mr and Mrs West.
- b) PA21/11035 and PA21/11036 extension to listed building at Rowse Farm for Miss K. Agutter.
- c) PA21/11170 and PA/11203 Replacement conservatory roof of listed building, Pillaton Barton farmhouse for Mr J. Humphrey.

Cllr Ley was thanked for presenting the plans on screen.

PURCHASE OF LAP TOP

The Council agreed to purchase a lap top for use by the Council.

NEIGHBOURHOOD DEVELOPMENT PLAN

The Council resolved to delay a decision on the carrying out of a housing survey and in the creation of a Neighbourhood Development plan until it discovered whether or not funding was possible.

PRECEPT

The Council agreed a precept of £4,890 for the year 2022 to 2023 being a reduction of £110 on the previous year.

PAYMENTS

The Council agreed the following payments; G. Moore £500 grass cutting, Duchy Defibrillators £336 and R. Woodley £19.09 stationery.

The Chairman thanked Mr Bridgman for cutting the hedges at the playing field at no cost to the Council.

ANY OTHER BUSINESS

The matter of parking was raised and it was decided that residents be asked through the Village News and Face book to be considerate when parking. The Clerk was asked to report pot holes at Pillaton Mill.
